

DECLARATION of consent to personal data processing

1.3 Data Transmitted Automatically:

- Cookies (data on website activity, IP address, browser type, information on actions necessary for the functioning of the service and for collecting statistics).

From the moment **EFFECTCOMM LLC** receives a notice of withdrawal of consent to the processing of personal data, access to the event area and personal account will be terminated.
