



## RULES FOR ACCREDITATION OF REPRESENTATIVES OF THE MEDIA AND BLOGOSPHERE FOR THE FINANCIAL CONGRESS OF THE BANK OF RUSSIA 2025

### 1. General Provisions.

1.1. Accreditation of representatives of the media (hereinafter referred to as the media) and the blogosphere for the Financial Congress of the Bank of Russia (hereinafter referred to as the Financial Congress) is carried out in order to ensure the necessary conditions for professional activities in the preparation and dissemination of complete and reliable information about the events of the Financial Congress.

1.2. When carrying out professional activities, representatives of the media and the blogosphere are obliged to respect the rights and legitimate interests of the participants and employees of the Financial Congress and comply with generally recognized ethical standards.

1.3. The number of representatives of the media and the blogosphere who can take part in the Financial Congress is limited: the organizers strive to provide the press and bloggers with the most comfortable working conditions and quick access to all necessary resources in the context of significant interest in the event and taking into account the limited infrastructure capabilities of the event site.

1.4. The Organizing Committee of the Financial Congress may increase the quota at the official request of the media, provided there is a reasoned justification for such a need.

### 2. Accreditation of media representatives and the blogosphere.

#### 2.1. Accreditation procedure.

Both Russian and foreign media representatives and the blogosphere can submit a registration application for participation in the Financial Congress, provided that:

Russian media must be registered with the Federal Service for Supervision of Communications, Information Technology, and Mass Media (hereinafter referred to as Roskomnadzor).

Foreign media representatives:

- 1) in the case of permanent work in the territory of the Russian Federation, must be accredited with the Russian Ministry of Foreign Affairs;
- 2) in the absence of accreditation with the Russian MFA, in addition to the application on the official website of the Financial Congress, it is necessary to apply for temporary accreditation at the Russian MFA.

Representatives of the blogosphere must indicate links to their blogs in the application for accreditation.



## 2.2. The procedure for submitting and reviewing an application for accreditation.

Representatives of the media and the blogosphere who wish to take part in covering the events of the Financial Congress must submit an application in the "Registration" section (hereinafter referred to as the application) through the official website of the Financial Congress (ifcongress.ru).

All fields must be filled in the application.

The deadline for submitting applications through the official website of the Financial Congress is July 2, 2025.

The application review period is from 10 calendar days.

Accreditation of representatives of the media and the blogosphere is valid on all days of the Financial Congress.

## 2.3. The procedure for issuing accreditation badges.

Representatives of the media and the blogosphere will receive badges subject to the approval of the registration application by the Organizing Committee of the Financial Congress. Badges will be issued at the registration desk of the Financial Congress venue. Information on the location and working hours of the registration desk will be available in the Personal Account of the participant of the Financial Congress.

Accreditation badges can only be issued if the following conditions are met:

- if accreditation is confirmed in the database of the Financial Congress;
- upon presentation of a passport.

Additional documents that the organizers may request:

- for representatives of Russian media - editorial ID;
- for representatives of foreign media - an accreditation card of the Russian Ministry of Foreign Affairs.

The badge is personalized, and must not be transferred to third parties during the work of the Financial Congress. The badge must be worn in a visible place for the entire time spent at the Financial Congress venue.

Any other accreditation cards are not valid for entry to the Financial Congress venue.

If the accreditation badge is lost or stolen, the media or blogosphere representative must immediately report it to an employee of any information desk. The lost badge will be blocked.

## 2.4. Rules for access to the events of the Financial Congress.

Accreditation of media and blogosphere representatives is mandatory for work at all events of the Financial Congress.



### 3. Refusal of accreditation.

The Organizing Committee of the Financial Congress reserves the right to refuse accreditation without explanation.

### 4. Rights and obligations of media and blogosphere representatives accredited to the Financial Congress.

4.1. A media and blogosphere representative accredited to the Financial Congress has the right to:

- use all services specially designed for journalists and press service employees;
- receive information about official events and exhibitions of the Financial Congress (press releases, business program, etc.);
- work in the press center of the Financial Congress during official events, using its infrastructure;
- participate in open press conferences, briefings and other press events that are held for all accredited media and bloggers.

4.2. A representative of the media and blogosphere accredited to the Financial Congress is obliged to:

When using official information and quoting statements by participants of the Financial Congress, follow the "Mention Policy" of the Financial Congress, namely: the finished materials must contain a mention of the Financial Congress and the source of the information received, and for electronic media - a link to the official website of the Financial Congress ([ifcongress.ru](http://ifcongress.ru)); making any changes, additions or distortions to the copied (quoted) information is not allowed.
